

MEMBERSHIP TYPES

Active Membership

For attorneys admitted to practice law in any U.S. State, District of Columbia or Puerto Rico, and reside in or practice in New York State. Active Members vote and hold office in AABANY. Includes affiliate membership with the National Asian Pacific American Bar Association (NAPABA).

- *Private Practice*: \$50 per year
- *Public Sector*: \$30 per year

The following includes recognition in our publications and at our annual banquet:

- *Patron*: \$100 per year
- *Life*: \$200 one time fee; must have been an AABANY member for 20 or more years

Associate Membership

For law students and paralegals not admitted to practice law but interested in AABANY's mission. Associate members do not vote or hold office in AABANY, and does not include NAPABA membership

- *Paralegals not admitted to practice*: \$30 per year
- *Law Students*: \$5 per year
- *Attorneys retired from the practice of law who have been AABANY Active Members for 3 years*: FREE upon registration.

The membership year runs from February 1st through January 31st of the following year. Memberships for new members joining after October 31st will extend until January 31st of the second year.
